

Directory of Designated Personnel for ICD-10 Training in the PhilHealth Regional Offices

In order to ensure the proper implementation of All Cases Rate Policies as provided in PhilHealth Circular nos. 31 and 35 s-2013 (Implementing Guidelines on Medical and Procedure Case Rates) particularly on the requirement for correct and complete International Classification of Diseases (ICD) – 10 codes in filling out the PhilHealth Claim Forms, The Standards and Monitoring Department (SMD) enjoins all PhilHealth Regional Offices (PROs) to provide assistance to hospitals and other relevant stakeholders in their training needs for ICD-10 coding.
