: MEDICAL DIRECTORS AND ADMINISTRATORS OF ALL PHILHEALTH ACCREDITED HOSPITALS AND MANAGERS OF REGIONAL HEALTH INSURANCE OFFICES.

SUBJECT

: AMENDMENTS TO MEMORANDUM CIRCULAR No. 056 s. 1999.

In view of the revision of the Implementing Rules and Regulation of Republic Act 7875, otherwise known as the National Health Insurance Act of 1995, the following amendments to Memorandum Circular 056 s. 1999 on the guidelines regarding the use of the official Admission Logbook by Philhealth accredited hospitals, one of the continuing requisites of accreditation are hereby issued:

- (1.) The Admission logbook should have the required 12 columns heading of which are as items (a.) to (l.) below and should be properly and completely accomplished as follows:
  - (a.) case number
  - (b.) date and time of admission
  - (c.) complete name of patient
  - (d.) age
  - (e.) sex
  - (f.) complete residential/office address
  - (g.) membership

- (2.) Individually -paying:
  - SM Self-employed-member

  - OT Others
- (3.) Indigent:
- IM Indigent-member
- ID Indigent-dependent
- (4.) Pensioner/Retiree:

  - NN Non-NHIP
- (h.) admitting diagnosis

(2.) At the end of every month, the Chief of Hospital or Medical Director should accomplish the monthly summary of hospital activities in the Admission Logbook as follows:

Non-compliance hereof shall be regarded as a violation of Section 59 Item (g.) and a Breach of Warranties under Section 157 of the IRR of R.A. 7875. Said offense shall be punishable with a fine of not less than Ten Thousand (P 10,000) pesos but not more than fifty Thousand (P 50,000) pesos, and three months suspension from participation in the NHIP to revocation of accreditation.

All other provisions of Philhealth Circular No. 056 s. 1999 not inconsistent herewith shall remain in force and in effect.
