ALL PHILHEALTH MEMBERS COMING FROM NATIONAL GOVERNMENT AGENCIES, LOCAL GOVERNMENT UNITS, GOVERNMENT-OWNED AND CONTROLLED CORPORATIONS, PRIVATE SECTOR EMPLOYERS, INDIVIDUALLY PAYING MEMBERS, NON-PAYING MEMBERS AND ALL OTHERS CONCERNED

SUBJECT :

Use of PhilHealth Identification Number (PIN) and PhilHealth Employer Number (PEN) in PhilHealth transactions

Effective January 1, 2003, all PhilHealth members from the government and private sector and their respective employers, Individually Paying Members (IPM) and Non-Paying Members (NPM) shall be required to use their PhilHealth Numbers to expedite certain transactions with the Corporation.

As such, employers who have not been issued their respective PhilHealth Employer Number (PEN) are directed to register with any of the PhilHealth offices nationwide. Employees who have not been issued their PhilHealth Identification Numbers (PIN) should coordinate with their respective employers to facilitate the issuance thereof.

On the other hand, retirees and pensioners from the government and private sector who are now considered Non-Paying Members are encouraged to formally enlist with PhilHealth for the issuance of their ID cards which indicate their respective PINs.

Those concerned are advised to duly accomplish and submit to any PhilHealth office the following registration form/s, whichever is/are applicable:
