In accordance with the following provisions under the Revised Implementing Rules and Regulations of R.A. 9184,"Government Procurement Reform Act", any modifications in the mode of procurement, technical specifications and Approved Budget for the Contracts including procurement of new items/projects shall be reflected in the Amended Approved Annual Procurement Plan (APP) for the applicable year through the end-user's submission of updated PPMP:
