SUBJECT: Approval Of Supplemental Annual Procurement Plan No.4

In order to ensure the effective and efficient delivery of public service and to reflect the necessary adjustments/revisions resulting from factors beyond reasonable planning such as price fluctuations and introduction of new or complementary programs, there necessitate an adjustment or revision in the approved APP. After judicious review and evaluation, the request for revisions/modifications in programs by proper parties, is deemed significant and necessary to the efficient discharge of the government function of the Corporation.

It is emphasized that all procurement based on the 2023 APP and its amendments must be undertaken strictly in accordance with the terms, conditions, requirements provided in the law, its RIRR as well as relevant government and corporate procurement policies, rules and regulations subject to usual government auditing, accounting rules and regulations.
