SUBJECT: INDICATIVE ANNUAL PROCUREMENT PLAN FOR CY 2025

Accordingly, and under the authority granted by the PhilHealth Board of Directors to the President and CEO, and Regional Vice President, in case of PhilHealth Regional Offices, as Head of the Procuring Entity, this Order is hereby issued approving the attached Indicative APP for CY 2025 for Goods and Services, Information and Technology Resources and Infrastructure.

It is emphasized that all procurement based on the approved indicative APP for CY 2025 must be undertaken strictly in accordance with the terms, conditions and requirements provided in the law, its IRR, as well as relevant government and corporate procurement policies, rules and regulations, subject to usual government auditing and accounting rules and regulations.
