CONTRACT FOR CONSULTANCY SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This contract is made and entered into by and between:

The PHILIPPINE HEALTH INSURANCE CORPORATION a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. 7875 (as amended by Republic Act No. 9241), with principal office at 709 Citystate Center, Shaw Blvd., Brgy. Oranbo, Pasig City, and duly represented herein by its Secretary of Health and Chairman of PhilHealth Board, DR. ENRIQUE T. ONA hereinafter referred to as PHILHEALTH;

OSCAR F. PICAZO, of legal age, and residing at 18F Tower 2, Olympic Heights, Eastwood, C-5 Road, Libis, Quezon City hereinafter referred to as the **CONSULTANT**;

WITNESSETH: that

WHEREAS, Phill lealth is mandated by law to ensure the health of all Filipinos under the National Health Insurance Program (NHIP) through the provision of minimum packages and other supplementary packages of health insurance benefits;

WHEREAS, consistent with the GOCC Governance Act of 2011, the current Board of Directors (BOD) is expected to discharge its duties and responsibilities with more care and diligence in conducting the business of the Corporation;

WHEREAS, there is a need to increase the capacity of PhilHealth Board to carry out its role under the social health insurance system, including understanding completely the policy proposals presented by the Management;

WHEREAS, for the above-stated purpose, Phill lealth needs to contract the services of a health policy and financing consultant to provide technical assistance in organizing, facilitating and documenting the policy discussions between the Board of Directors and the Management which shall be financed through the grant provided by World Bank through its Institutional Development Fund (IDF);

WHEREAS, this agreement shall not be construed as creating an employer-employee relationship in some manner or form between the Consultant and PhilHealth, hence, the latter shall not be responsible for complying with any labor laws, rules and regulations governing employer-employee relationships in the Philippines;

WHEREAS, the parties herein knowingly, voluntarily, without any force, duress, or improper pressure, and dealing with each other on equal terms with neither dominance on the other, hereby agree to the present Agreement;

NOW, THEREFORE, for an in consideration of the premises, the parties have mutually agreed the following terms and conditions:

1. Services

The Consultant shall undertake and perform the following functions:

- a) Organize the health policy discussion s that will provide the venue for the Management to present PhilHealth proposed policies to the Board of Directors. This includes inviting 1-2 external panelists to participate in the discussion;
- b) Synthesize the policy discussion and highlight the important issues that must be addressed in finalizing the policy;

- c) Provide advice to the Chairman of the Board on international/local experiences related to the policy, when needed; and
- d) Policy Notes to address policy questions related to KP implementation raised by the Board of Directors when necessary.

2. Term

The Consultant shall be engaged for a period of three (3) months spread over one (1) year at the rate of One Million Eighty Thousand Pesos (Php1,080,000.00) to be funded from the World Bank – IDF Grant.

3. Compensation

The Consultant shall be compensated based on the terms of payments for each of the following deliverables:

Upon approval of the Inception Report	20%
Upon submission of 50% of health policy discussions	40%
based on indicative list	
Upon submission of 70% of health policy discussions	40%
based on indicative list	

4. **Program Administration**

The Consultant will report directly to the Chairman of the Board in coordination with the Office of the President and Chief Executive Officer. The Chair will approve notices and acceptance of deliverables, activities and other related tasks

The World Bank shall be furnished a copy of all deliverables of the consultant in keeping with the conditions of the grant agreement.

5. Performance

The Consultant is expected to perform his duties faithfully and to the best of his ability, and to comply with the scope of work with the highest standards of professional and ethical competence and integrity.

6. Confidentiality

The Consultant shall not disclose any proprietary or confidential information relating to PhilHealth or to this agreement without prior written consent from the latter.

7. Data Ownership

All deliverables of the Consultant shall be the sole and exclusive property of PhilHealth and shall not be used for any other purposes other than what is stipulated under this Agreement. Immediately upon completion or termination of this engagement, the Consultant shall return all copies, files, documents, papers, materials, and any other property in his possession that belong or relate to the interest of PhilHealth.

Entire Agreement and Amendments 8.

This document constitutes the entire agreement between the PhilHealth and the Consultant, the provisions of which supersede any and all prior negotiations, understanding, or contracts relating to the same subject matter.

Any revision or amendment of this Agreement shall require the written consent of all parties.
