WHEREAS, it is imperative that IT security be given the highest level of importance in order to ensure the viability of this data and the confidentiality and privacy of its members.

WHEREAS, PhilHealth needs the services of an Information Technology Security Consultant to provide business and technical advice on a variety of security issues, concerns and problems in order to safeguard PhilHealth's IT infrastructure from unauthorized access, unapproved usage and threats to functionality/operation.

Scope of Consultancy Services

Compensation

Confidentiality

The Consultant shall not disclose any proprietary or confidential information relating to PhilHealth or to this agreement without prior written consent from the latter. For this purpose, the Consultant shall accordingly execute and faithfully abide by the Non-Disclosure Agreement (NDA) to be issued by PhilHealth which shall form an integral part of this Agreement.

Data Ownership

All deliverables of the Consultant shall be the sole and exclusive property of PhilHealth and shall not be used for any other purposes other than what is stipulated under this Immediately upon completion or termination of this engagement, the Agreement. Consultant shall return all copies, files, documents, papers, materials, and any other property in his possession that belong or relate to the interest of PhilHealth.

Amendments and Entirety of the Agreement

This document along with the identified annexes and attachments as specified in this Agreement shall constitute the entire agreement between PhilHealth and the Consultant. The specific provisions of this Consultancy Agreement shall supersede any and all prior negotiations, understanding, contracts and/or undertakings relating to the same subject matter.

Any revision or amendment of this Agreement shall require prior written consent of all parties.
