CONSULTANCY CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

This contract is made and entered into by and between:

The PHILIPPINE HEALTH INSURANCE CORPORATION a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. 7875 (as amended by Republic Act No. 9241), with principal office at 709 Citystate Center, Shaw Blvd., Brgy. Oranbo, Pasig City, duly represented herein by its President and Chief Executive Officer, DR. EDUARDO P. BANZON hereinafter referred to as PHILHEALTH;

and

RUBEN CANLAS, JR., of legal age, and residing at 402 Valle Verde Homes, Valle Verde 2, Pasig City hereinafter referred to as the CONSULTANT;

WITNESSETH: that

WHEREAS, PhilHealth is institutionalizing changes in line with its strategic imperatives in order to strengthen the implementation of the National Health Insurance Program as a driver towards achieving Kalusugan Pangkalahatan;

WHEREAS, the Corporation recognizes the need to properly restructure its information and communications technology sector to ensure that it is supportive of the performance accountability arrangements that PhilHealth will be implementing and the overall plans of the organization;

WHEREAS, for the above-stated purpose, PhilHealth needs to contract the services of an enterprise architecture and organizational change leadership consultant which shall be financed through the grant provided by World Bank through its Institutional Development Fund (IDF);

WHEREAS, this agreement shall not be construed as creating an employer-employee relationship in some manner or form between the Consultant and PhilHealth, hence, the latter shall not be responsible for complying with any labor laws, rules and regulations governing employer-employee relationships in the Philippines;

WHEREAS, the parties herein knowingly, voluntarily, without any force, duress, or improper pressure, and dealing with each other on equal terms with neither exercising moral dominance on the other, hereby agree to the present Agreement;

NOW, THEREFORE, for and in consideration of the premises, the parties have mutually agreed the following terms and conditions:

1. Services

The Consultant shall undertake and perform the following functions:

- a. Define the objectives, scope and framework for a PhilHealth Enterprise Architecture (PEA) that are aligned with the organization's vision, mission, objectives and mandate.
- b. Describe the "as-is" or current state of IT infrastructure and the "to be" or future state of enterprise architecture at PhilHealth, highlighting the gaps and recommending options for transitioning to the "to-be" state.
- c. Draft a paper describing the PhilHealth Enterprise Architecture including strategy options and timeline for achieving the "to-be" state.
- d. Based on the PhilHealth Enterprise Architecture document, define the skills and competencies needed to enable the recommended enterprise architecture.
- e. Work closely with the change management consultants and organizational development consultant, integrating their work into the organizational change process.
- f. Assist in other projects of the Office of the President and CEO and perform other duties related to his services as required.

2. Term

The Consultant shall be engaged for a period of eighteen (18) months at the rate of One Million One Six Hundred Eighty-Seven Five Hundred Pesos (Php1,687,500.00) to be funded from the World Bank – IDF Grant.

3. Compensation

The Consultant shall be compensated based on the terms of payments for each of the following deliverables:

Upon approval of the Inception Report	15%
Upon submission of IT Diagnostic Report	25%
Upon initial implementation of the Change Management Plan	35%
Upon submission of Final Report	25%

4. Program Administration

The Consultant will report directly to the President & Chief Executive Officer (PCEO) in coordination with the Chief Information Officer. The PCEO and CIO will approve notices and acceptance of deliverables, activities and other related tasks.

The World Bank shall be furnished a copy of all deliverables of the consultant in keeping with the conditions of the grant agreement.

5. Performance

The Consultant is expected to perform his duties faithfully and to the best of his ability, and to comply with the scope of work with the highest standards of professional and ethical competence and integrity.

6. Confidentiality

The Consultant shall not disclose any proprietary or confidential information relating to PhilHealth or to this agreement without prior written consent from the latter.

7. Data Ownership

All deliverables of the Consultant shall be the sole and exclusive property of PhilHealth and shall not be used for any other purposes other than what is stipulated under this Agreement. Immediately upon completion or termination of this engagement, the Consultant shall return all copies, files, documents, papers, materials, and any other property in his possession that belong or relate to the interest of PhilHealth.

8. Entire Agreement and Amendments

This document constitutes the entire agreement between the PhilHealth and the Consultant, the provisions of which supersede any and all prior negotiations, understanding, or contracts relating to the same subject matter.

Any revision or amendment of this Agreement shall require the written consent of all parties.

9. Dispute Resolution

The parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this Agreement or the interpretation thereof. Any dispute as to matters arising pursuant to this Agreement which cannot be settled amicably within sixty (60) days after recipt by one party of the other party's request for such amicle settlement may be submitted by either party for arbitration in accordance with provision of RA 9285 otherwise known as the "Alternative Dispute Resolution Act of 2004"
