

**KNOW ALL MEN BY THESE PRESENTS:**

This contract is made and entered into by and between:

The **PHILIPPINE HEALTH INSURANCE CORPORATION** a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. 7875 (as amended by Republic Act No. 9241), with principal office at 709 Citystate Center, Shaw Blvd., Brgy. Oranbo, Pasig City, and duly represented herein by its President and Chief Executive Officer, **DR. EDUARDO P. BANZON** hereinafter referred to as **PHILHEALTH**;

and

**DR. PERCY G. BALDERIA**, of legal age, and residing at 2625 Taft Avenue, Brgy. 719, Zone 078, Malate, Manila hereinafter referred to as the **CONSULTANT**;

**WITNESSETH: that**

**WHEREAS**, PhilHealth is mandated to provide financial risk protection to its members by providing affordable, accessible and adequate health care services and supplementary benefit packages under the National Health Insurance Program;

**WHEREAS**, pursuant to its plan of improving and ensuring better protection for its members, PhilHealth plans to roll-out a series of enhanced benefits which includes shifting from the current fee-for-service to the Case Rate payment system and developing a Primary Care Benefits;

**WHEREAS**, for the above-stated purpose, PhilHealth needs to contract the services of a primary care benefits and case rates consultant to create and help provide additional medical perspective in the design of an evidence-based benefit package that is relevant to the Philippine healthcare setting;

**NOW, THEREFORE**, for and in consideration of the premises, the parties have mutually agreed the following terms and conditions:

**1. Services**

The Consultant shall undertake and perform the following functions:

- a) Review literature relevant to the Primary Care Benefit and Case Rates Package;
- b) Contribute substantial input to development of the Primary Care Benefit and Case Rates Package including work plans along with actual benefit and incentive design;
- c) Represent the program in coordination meetings, staff meetings, workshops, and meetings with the Office of the President and other stakeholders;
- d) Assist in authoring research reports, briefing notes, circulars, board resolutions and other materials as required;
- e) Help to develop and coordinate dissemination of the Primary Care Benefit and Case Rates Package to its internal and external stakeholders and do follow-up activities, including providing substantive advice on the future direction of the program;
- f) Design a Monitoring and Evaluation scheme with regards to the impact of the Primary Care Benefit and Case Rates, especially with regards to improvement of quality of care in inpatient and outpatient settings; and
- g) Provide insights into the findings of the Monitoring and Evaluation.

**2. Term**

The Consultant shall be engaged for a period of **six (6) months** at the total rate of **One Hundred Eighty-Seven Thousand and Five Hundred Pesos**

3. **Compensation**

The Consultant shall be compensated on a monthly basis in the amount of **Thirty One Thousand Two Hundred Fifty Pesos (Php31,250.00)** upon submission of a monthly report to the Senior Manager for Benefits Development and Research Department.

4. **Program Administration**

The Consultant will report directly to the Office of the President and CEO and Senior Manager for Benefits Development and Research Department. The PCEO will approve notices and acceptance of deliverables, activities and other related tasks.

5. **Performance**

The Consultant is expected to perform his duties faithfully and to the best of his ability, and to comply with the scope of work with the highest standards of professional and ethical competence and integrity.

6. **Confidentiality**

The Consultant shall not disclose any proprietary or confidential information relating to PhilHealth or to this agreement without prior written consent from the latter.

7. **Data Ownership**

All deliverables of the Consultant shall be the sole and exclusive property of PhilHealth and shall not be used for any other purposes other than what is stipulated under this Agreement. Immediately upon completion or termination of this engagement, the Consultant shall return all copies, files, documents, papers, materials, and any other property in his possession that belong or relate to the interest of PhilHealth.

8. **Entire Agreement and Amendments**

This document constitutes the entire agreement between the PhilHealth and the Consultant, the provisions of which supersede any and all prior negotiations, understanding, or contracts relating to the same subject matter.

Any revision or amendment of this Agreement shall require the written consent of all parties.

9. **Effectivity**


The parties hereby accept the terms of this Agreement and have hereunto set their hands this 24th day of MAY, 2012, at PASIG CITY, Philippines.


