

CONTRACT OF SERVICE

This contract is made and entered into by and between the **PHILIPPINE HEALTH INSURANCE CORPORATION**, represented herein by **RAMON F. ARISTOZA, JR., RVP-PROXII**, herein after referred to as **FIRST PARTY** and **DE JESUS CALTEX SUPER SERVICE STATION** represented by **JESUS L. WITNESSETH:

That the **SECOND PARTY** binds itself to provide fuel, oil, labor and materials for the Repair and Maintenance Services of the **FIRST PARTY'S** vehicles from **January 01, 2012 to December 31, 2012**, renewal upon agreement of the parties.

Whenever necessary the following are the duties and responsibilities of the **SECOND PARTY**:

1. Change oil/labor
2. Engine/body/under wash
3. Vacuum Cleaning
4. Tune up
5. Provide the supplies needed for the repair and maintenance of **PHILHEALTH** vehicles and other services as may be necessary.

That in consideration for the Services rendered, the **SECOND PARTY** shall submit its bill every 15th and end of the month. The **FIRST PARTY** shall pay the former within 15 days upon receipt of the billing statement. Provided, that payments shall be in the form of check payable to **DE JESUS CALTEX SUPER SERVICE STATION**.


