- 3. That the Contractor shall provide special or fast lane for PhRO II employees;
- 4. That the Contractor shall provide male (responsible in performing physical examinations to PhRO II male employees) and female (responsible in performing physical health examinations to PhRO II female employees) examining physicians who shall give priority and finish the physical examinations of Philhealth employees sent in batches on particular scheduled date;
- That the Contractor shall provide a substitute examining physician/s, in case of unavailability of the designated examining physician/s on a particular scheduled day of examination;
- Include eye check-up/fundoscopy, as part of the physical examination, for identified employees who are chauffeurs;
- Include initial dental check-up for all regular employees who did not have any single dental examination yet;
- 8. That the Contractor shall furnish PhRO 2 copy of the laboratory results within five (5) days after the examination (with a summary of significant medical findings and laboratory examinations done, using the template to be provided by PhRO 2;
- In case the employee of Philhealth fails to undergo PHEX on his/her designated scheduled date of examination, the hospital shall conduct on the re-scheduled date upon presentation of a referral slip to be issued by PhRO 2 Health Designate, within the contract period;
- 10. In case of repeat laboratory test/s or follow-up diagnostic procedure/s or referral to specialty doctors, the contracted annual PHEx provider shall also grant discounts on said laboratory work-up/s and professional fees, being a government employee client/patient;
- 11. Initial records of patients with laboratory results or duplicates shall be made available to PhilHealth upon request, as the need arises, but only if request slip has been provided by the PRO2 Health Designate;
- 12. In case there is an adjustment on the last day of scheduled date, the contracted PHEx provider shall be amenable to any adjustment favorable to the client, but not to go beyond three months of extension.
- 13. That PHILHEALTH shall pay the amount due and payable under this contract upon presentation by the Contractor of the corresponding Statement of Account, exclusive of any incidental expense that may be incurred by PHILHEALTH during this activity, subject to the availability of funds and the usual government accounting and auditing rules;
