

**CONTRACT AGREEMENT  
TO PROVIDE PHILHEALTH REGIONAL OFFICE III  
WITH LEASE OF VENUE / CATERING SERVICES  
FOR AREA 1 SERVICE OFFICE SUMMIT**

THIS AGREEMENT made the \_\_\_\_\_ day of \_\_\_\_\_, 2011 between **PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE III (PHRO-III)** with business address at *PhilHealth Bldg., Lazatin Blvd., San Agustin, City of San Fernando, Pampanga* (hereinafter called "**the Entity**") of the one part and **HOLIDAY INN, CLARK PHILIPPINES** with business address at *Mimosa Drive, Mimosa Leisure Estate, Clark Freeport Zone, Philippines 2023* (hereinafter called "**the Supplier**") of the other part:

WHEREAS, the Entity requested for Quotations from three (3) Venue/Catering Providers of known qualifications in Angeles City for certain goods, viz: **Lease of Venue / Catering Services for Area 1 Service Office Summit** and has accepted a quotation by the Supplier for the provision of those goods in the sum of **PESOS: THREE HUNDRED SIXTY TWO THOUSAND AND EIGHT HUNDRED (P 362, 800.00)** hereinafter called "**the Contract Price**".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (a) the Bid Form/Proposal(Quotation) and the Schedule of Bid Prices submitted by the Winning Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Approved Terms of Reference;
  - (d) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the said goods and to remedy any defect(s) therein, in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the aforementioned goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at this time and in the manner prescribed by the Contract.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
