

**CONTRACT AGREEMENT**  
**TO PROVIDE PHILHEALTH REGIONAL OFFICE III**  
**WITH ONE (1) LOT GENERATOR SETS**

THIS AGREEMENT made the \_\_\_\_\_ day of JUN 19 2012, 2012 between **PHILIPPINE HEALTH INSURANCE CORPORATION** (PhilHealth for brevity), a government owned and controlled corporation duly created and existing by virtue of R.A. No. 7875 with principal office at City State Center Building, 709 Shaw Blvd., cor. Oranbo Drive, Pasig City, represented herein by its Vice President for Regional Office III, **RODOLFO M. BALOG**, with business address at *PhilHealth Bldg., Lazatin Blvd., San Agustin, City of San Fernando, Pampanga* (hereinafter called "**the Entity**") of the one part and **FIL POWER GROUP & MARKETING CORPORATION**, a corporation duly organized and existing under the laws of the Philippines, with principal office at Door No. 3, St. Anthony Building, Lopez Jaena St., Bacolod City, represented herein by its authorized representative, **ROBINSON L. BERMEJO, JR.**, with the same business address (hereinafter called "**the Supplier**") of the other part:

WHEREAS, the Entity posted its Invitation to Bid for certain goods, viz: **One (1) Lot Generator Sets** in the PhilGEPS, PhilHealth website, newspaper of general circulation and in conspicuous places within PhilHealth Building and has accepted a quotation by the Supplier for the provision of those goods in the sum of **PESOS: TWO MILLION FOUR HUNDRED SIXTY-EIGHT THOUSAND (P 2,468, 000.00)** hereinafter called "**the Contract Price**".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (a) the Bid Form/Proposal(Quotation) and the Schedule of Bid Prices submitted by the Winning Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Approved Terms of Reference;
  - (d) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the said goods and to remedy any defect(s) therein, in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the aforementioned goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at this time and in the manner prescribed by the Contract.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
