

**CONTRACT AGREEMENT
TO PROVIDE PHILHEALTH REGIONAL OFFICE III
WITH IT EQUIPMENT: 1 LOT OF WIRELESS NETWORK IP CAMERA**

THIS AGREEMENT made the MAR 22 2012 day of 2012, 2012 between **PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE III (PHRO-III)** with business address at *PhilHealth Bldg., Lazatin Blvd., San Agustin, City of San Fernando, Pampanga* (hereinafter called "**the Entity**") of the one part and **AMPY'S PC COMSHOP** with business address at *Santos Bldg., Capitol Drive, San Jose, Balanga City* (hereinafter called "**the Supplier**") of the other part:

WHEREAS, the Entity invited Bids for certain goods, viz: **IT Equipment [1 Lot of Wireless Network IP Camera (Procurement and Installation of 18 units of Wireless Network IP Camera for the Different Offices of PhilHealth Regional Office III)]** and has accepted a Bid by the Supplier for the provision of those goods in the sum of **SEVEN HUNDRED TEN THOUSAND PESOS ONLY (P 710,000.00)** hereinafter called "**the Contract Price**".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

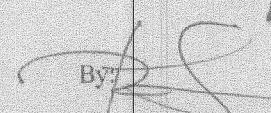
1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Schedule of Bid Prices submitted by the Winning Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of the Contract;
 - (e) the Special Conditions of the Contract; and
 - (f) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the said goods and to remedy any defect(s) therein, in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the aforementioned goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at this time and in the manner prescribed by the Contract.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.

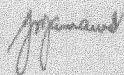

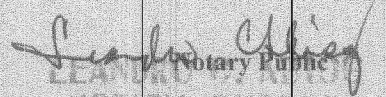
