

CONTRACT AGREEMENT
TO PROVIDE PHILHEALTH REGIONAL OFFICE III
WITH 1 LOT OFFICE EQUIPMENT (12 UNITS REFRIGERATOR AND 11
UNITS TELEVISION SET)

THIS AGREEMENT made this _____ day of JAN 16 2013 between **PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE III (PhRO-III)** with business address at PhilHealth Building, Lazatin Boulevard, San Agustin, City of San Fernando, Pampanga (hereinafter called "**the Entity**") of the one part and **McSA MARKETING** represented in this Act by **MS. TERESA S. AGSALUD** with business address at GF Gedisco Building, #446 San Fernando Street, Binondo, Manila (hereinafter called "**the Supplier**") of the other part:

WHEREAS, the Entity invited Bids for certain goods, viz: **1 lot Office Equipment (12 Units Refrigerator and 11 Units Television Set)** and has accepted a Bid by the Supplier for the provision of those goods in the sum of **PESOS: SIX HUNDRED SIXTY-FIVE THOUSAND SEVEN HUNDRED THIRTY-SEVEN AND 50/100 PESOS ONLY (P 665,737.50)** hereinafter called "**the Contract Price**".


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Schedule of Bid Prices submitted by the Winning Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of the Contract;
 - (e) the Special Conditions of the Contract; and
 - (f) the Entity's Notice of Awards
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenant with the Entity to provide the said goods and to remedy any defect(s) therein, in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenant to pay the Supplier in consideration of the provision of the aforementioned goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at this time and in the manner prescribed by the Contract.

IN WITNESS WHEREOF, the parties hereto have caused the Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


