

CONTRACT AGREEMENT
TO PROVIDE PHILHEALTH REGIONAL OFFICE IV-A
PHILHEALTH RUN 2013 EVENT / RACE ORGANIZER GOODS AND SERVICE

THIS AGREEMENT made this 28th day of December 2012 between **PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IV-A (PRO IVA)** with business address at **AMCJ Square Building, Diversion Road, Brgy. Bocohan, Lucena City** (hereinafter called "the Entity") of the one part and **GLOBAL EXCELLENCE EVENTS AND PROMOTIONS** with business address at **Rosales Compound, Brgy. Wakas, Tayabas City** (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **PHILHEALTH RUN 2013 EVENT / RACE ORGANIZER** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE HUNDRED FORTY NINE THOUSAND PESOS (Php 949,000.00)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable Under the provisions of the Contract at the time and in the manner prescribed by the contract.
5. The Supplier hereby covenants to deliver in favour of the Entity the goods and services based on Technical Specifications of this Contract.

IN WITNESS whereof, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.

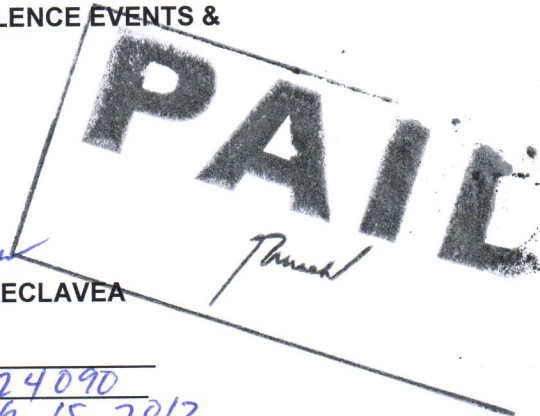


