CONTRACT AGREEMENT TO PROVIDE PHILHEALTH REGIONAL OFFICE IV-A SUPPLY AND DELIVERY OF STORAGE CABINETS

THIS AGREEMENT made this ______ day of June 2012 between PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IV-A (PRO IVA) with business address at AMCJ Square Building Diversion Road, Brgy. Bocohan, Lucena City (hereinafter called "the Entity") of the one part and MCSA MARKETING with business address at GF Gedisco Bldg. 446 San Fernando St., Binondo, Manila (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **SUPPLY AND DELIVERY OF STORAGE CABINETS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE HUNDRED NINETY FIVE THOUSAND FIVE HUNDRED THIRTY SIX PESOS ONLY (PhP 195,536.00)** (hereinafter called "the Contract Price").

 - (b) the Schedule of Requirements;

 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
