

CONTRACT FOR CY 2012 3rd QUARTER COMMON OFFICE SUPPLIES

This Contract is made and entered into on _____ by and between:

PHILIPPINE HEALTH INSURANCE CORPORATION - REGIONAL OFFICE VI with business address at Majestic Building, No. 15 J. De Leon St., Iloilo City, herein represented by its Regional Vice-President, **DENNIS S. MAS, PhD URP**, and hereinafter referred to as "**PHILHEALTH**", and

UNI - ART SUPPLY with business address at Iznart St., Iloilo City, Iloilo, herein represented by its Owner/Proprietor, **MR. OSCAR C. TE**, and hereinafter referred to as the "**SUPPLIER**";

WITNESSETH:

WHEREAS, PHILHEALTH invited Bids for certain goods and ancillary services, viz., **CY 2012 3rd Quarter Common Office Supplies** and has accepted the Bid by **Uni-Art Supply** for the supply of those goods in the sum of **TWO HUNDRED FIFTY FIVE THOUSAND THREE HUNDRED SIXTY PESOS and 20/100 (PHP 255,360.20)**, Philippine currency, hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. The Bid Form and the Price Schedule submitted by the Bidder;
 - b. The Schedule of Requirements;
 - c. The Technical Specifications;
 - d. The Terms of Reference and its Supplemental Bid Bulletin;
 - e. The General Conditions of Contract;
 - f. The Special Conditions of Contract; and
 - g. The Entity's Notification of Award.
3. In consideration of the payments to be made by **PHILHEALTH** to the "**SUPPLIER**" as hereinafter mentioned, the "**SUPPLIER**" hereby covenants with **PHILHEALTH** to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. **PHILHEALTH** hereby covenants to pay the "**SUPPLIER**" in consideration of the delivery of the CY 2012 3rd Quarter Common Office Supplies and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. **PHILHEALTH** shall impose a penalty in the amount equivalent to 1/10 of 1 percent of the value of the undelivered CY 2012 3rd Quarter Common Office Supplies for each day of the delay as liquidated damages.
6. **PHILHEALTH** shall hold ten percent (10%) of the total contract price as retention money or as obligation for the "Warranty" in an amount equivalent to Twenty Five Thousand Five Hundred Thirty Six and 2/100 (Php 25,536.02). Said amount shall only be released after the lapse of the warranty period as required under Section 62 (Warranty) of the IRR of RA 9184. Provided, however, that the goods supplied are free from patent and latent defects and all the conditions imposed under this Agreement have been fully met. Provided further, that the "**SUPPLIER**" may opt to post a special bank guarantee to at least ten percent (10%) of the total contract price. The said special bank guarantee shall have a validity period covering the whole duration of the warranty period of three (3) months.
