

# CONTRACT for SECURITY SERVICES

This Contract for Security Services is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_ in the City of Iloilo, Philippines, by and between:

**PHILIPPINE HEALTH INSURANCE CORPORATION - REGIONAL OFFICE VI** with business address at Majestic Building, No. 15 J. De Leon St., Iloilo City and hereinafter referred to as "**PHILHEALTH**"; - and -

**LIFEGUARD ARCHANGEL SECURITY AGENCY CORP.** with business address at Unit 205, Jovan Condo, No. 600, Shaw Blvd. cor. Samat St., Mandaluyong City and hereinafter referred to as the "**SUPPLIER**";

## WITNESSETH:

**WHEREAS, PHILHEALTH** invited Bids for certain goods and ancillary services, viz., **SECURITY SERVICES** and has accepted the Bid by **LIFEGUARD ARCHANGEL SECURITY AGENCY CORP.** for the supply of security services in the sum of **Two Million Six Hundred Thirteen Thousand Six Hundred Ninety Seven Pesos and 20/100 (Php 2,613,697.20)** hereinafter called "the Contract Price".

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a. The Bid Form, the supplemental bids thereto, and the Price Schedule submitted by the Bidder;
  - b. The Schedule of Requirements;
  - c. The Technical Specifications;
  - d. The Terms of Reference;
  - e. The General Conditions of Contract;
  - f. The Special Conditions of Contract;
  - g. The Entity's Notification of Award; and
  - h. The Revenue Memorandum Circular No. 39-2007 issued by the Bureau of Internal Revenue.
3. In consideration of the payments to be made by PHILHEALTH to LIFEGUARD ARCHANGELS SECURITY AGENCY CORP. as hereinafter mentioned, LIFEGUARD ARCHANGELS SECURITY AGENCY CORP. hereby covenants with PHILHEALTH to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. PHILHEALTH hereby covenants to pay LIFEGUARD ARCHANGELS SECURITY AGENCY CORP. in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. This Contract for Security Services shall commence on January 1, 2012 to December 31, 2012.
