

Contract Agreement Form

THIS AGREEMENT made this 11th day of January 2013 between **PhilHealth Regional Office - CAR** (hereinafter called "the Entity") of the one part and DCI International I.T. Solutions and Services Corporation (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids of 1 lot I.T. Equipment and has accepted a Bid by the Supplier for the supply of said goods in the sum of **Two Million Seven Hundred Forty Nine Thousand and Fifty Eight Pesos (PhP2,749,058.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
3. The Entity hereby covenants to pay the Supplier the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed therein.
4. In consideration of the payments to be made by the Entity to the Supplier as aforementioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract




