

**CONTRACT AGREEMENT  
TO PROVIDE PHILHEALTH REGIONAL OFFICE X  
SUPPLY AND DELIVERY OF 78 PIECES STEEL RACK**

THIS AGREEMENT made this \_\_\_\_\_ day of October 2013 by and between **PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE X (PRO-X)** with business address at 6<sup>th</sup> Floor Trinidad Building, Yacapin-Corrales Streets, Cagayan de Oro City (hereinafter called "the *Entity*") of the one part, and **REAL FORM FURNITURE SHOP** with business address at #22 Saturn St., Bricktown Subdivision, Moonwalk, Parañaque City, Metro Manila (hereinafter called "the *Supplier*") of the other part;

WHEREAS, the *Entity* invited Bids for certain goods and ancillary services, viz., **SUPPLY AND DELIVERY OF 78 PIECES STEEL RACK** and has accepted a Bid by the *Supplier* for the supply of those goods and services in the sum of **FIVE HUNDRED NINETY-THREE THOUSAND NINE HUNDRED NINETY-NINE PESOS & 64/100 (Php593,999.64)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (a) The Bid form and the Price Schedule submitted by the Bidder;
  - (b) The Schedule of Requirements;
  - (c) The Technical Specifications;
  - (d) The General Conditions of the Contract;
  - (e) The Special Conditions of the Contract; and
  - (f) The Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


