CONTRACT TO PROVIDE PHILHEALTH REGIONAL OFFICE IV-A VARIOUS IT EQUIPMENT

THIS AGREEMENT made this 9th day of May 2013 between *PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IV-A (PRO IVA)* with business address at AMCJ Square Building Diversion Road, Brgy. Bocohan, Lucena City (hereinafter called "the Entity") of the one part and *HLYC Trading* with business address at 1133E Aguilar St., Sta. Cruz, Manila City (hereinafter called "the Supplier") of the other part:

 - (f) the Entity's Notification of Award.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
