CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

The PHILIPPINE HEALTH INSURANCE CORPORATION, a government owned and controlled corporation, existing by virtue of Republic Act 7875 as amended by RA 9241 and RA 10606, otherwise known as the "National Health Insurance Act of 1995", with Regional Office Address at the Builders Place, Del Rosario St., Tuguegarao City, represented by its Regional Vice President, MR. OSCAR B. ABADU, JR, hereinafter referred to as "PHILHEALTH",

-AND-

INTELLIGENT DEPOT, a private enterprise, organized and existing under pertinent laws of the Republic of the Philippines, with business address at Baligata, Ilagan, Province of Isabela, represented by its General Manager, MR. RAY L. BUENVIAJE, hereinafter referred to as the "SUPPLIER",

-WITNESSETH THAT-

WHEREAS, PHILHEALTH invited Bids for the procurement of brand new Furniture & Fixtures;

- 1. II. Terms of Delivery and Payment

- a. The furniture and fixtures shall be delivered within thirty (30) calendar days from the date of receipt of Notice to Proceed.
- b. The supplier must show samples of the subject procurement before delivery.

III. Warranty and Liquidated Damages

- a. The supplier shall guarantee that the items are free from any patent and latent defects prior to acceptance. The items should be covered with a warranty for replacement within ninety (90) calendar days from the date of delivery.
- b. The obligation for the warranty shall be covered by a special bank guarantee equivalent to at least 10% of the total contract price. The said bank guarantee shall be issued by the supplier to the procuring entity prior to the implementation of the Purchase Contract. In turn, the procuring entity shall release the said bank after the lapse of one (1) quarter, provided that the goods delivered are free from patent and latent defects and all conditions imposed under the contract have been fully met.
- c. The procuring entity shall impose penalty in an amount to 1/10 of 1 percent of the total value of undelivered order for each day of delay as liquidated damages.

IV. Other Terms and Conditions

- a. The supplier must be affiliated with a local service center that will provide free technical services within the warranty period.
- b. For imported items, IMPORTATION DOCUMENTS specifically showing the condition, serial numbers of the equipment purchased, and tax receipts, should be submitted by the supplier.
- c. Prices are subject to tax which shall be withheld by the procuring entity for remittance to BIR. In turn, the procuring entity shall issue a Withholding Tax Certificate.

3. RESCISSION

In case any of the party violates any provision of this contract or for any justifiable or lawful cause, the aggrieved party may cause the rescission of this contract in accordance with existing laws.
