

**CONTRACT**  
**TO PROVIDE PHILHEALTH REGIONAL OFFICE IVA**  
**VARIOUS FURNITURE AND FIXTURES**  
**ITB#08-PB14**

THIS AGREEMENT made this 27<sup>th</sup> day of October 2014 between PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IVA (PRO IVA) with business address at Lucena Grand Terminal Inc., Brgy. Ilayang Dupay, Lucena City (hereinafter called "the Entity") of the one part and SEE MANUFACTURING CONTRACTOR with business address at 140 Aurora Blvd., San Juan City Metro Manila (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **SUPPLY AND DELIVERY OF VARIOUS FURNITURE AND FIXTURES FOR PRO IVA per ITB#08-PB14 (LOT 1 AND 2)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVEN HUNDRED EIGHTY THOUSAND THREE HUNDRED TWENTY PESOS ONLY (Php 780,320.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as parts of this Agreement, viz.:
  - (a) Bid Form and the Price Schedule submitted by the Bidder;
  - (b) Schedule of Requirements;
  - (c) Technical Specifications;
  - (d) General Conditions of Contract;
  - (e) Special Conditions of Contract; and
  - (f) Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


