CONTRACT TO PROVIDE PHILHEALTH REGIONAL OFFICE IVA VARIOUS FURNITURE AND FIXTURES ITB#08-PB14

THIS AGREEMENT made this 27th day of October 2014 between PHILIPPINE HEALTH INSURANCE CORPORATION REGIONAL OFFICE IVA (PRO IVA) with business address at Lucena Grand Terminal Inc., Brgy. Ilayang Dupay, Lucena City (hereinafter called "the Entity") of the one part and SEE MANUFACTURING CONTRACTOR with business address at 140 Aurora Blvd., San Juan City Metro Manila (hereinafter called "the Supplier") of the other part:

PHILIPPINE HEALTH INSURANCE

- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
