**WHEREAS**, PhilHealth Regional Office IX posted the Invitation to Bid for the Procurement of Three (3) Lots Bidding for the Supply and Delivery of IT Equipment at Philippine Government Electronic Procurement System (PhilGEPS), PHIC Corporate Website and conspicuous areas of PRO IX, continuously, from September 8 to 14, 2014 (7 calendar days);

**WHEREAS**, in response to the said advertisements, **GLOBAL CHIPS TECHNOLOGIES, MASANGKAY COMPUTER CENTER, EMCOR INC. and NG KHAI DEVELOPMENT CORPORATION**, acquired the bid documents for the project, submitted the required bid envelopes before 12:00 noon of September 29, 2014;

**WHEREAS**, upon careful examination, validation and verification of the Technical Component (Eligibility and Technical Documents) of the abovementioned prospective bidders during the Bid Opening on September 29, 2014, the following results were unanimously decided by the committee;

**WHEREAS**, Masangkay Computer Center submitted the required Certification from Bureau of Permits, City of Manila dated October 1, 2014 with Certificate No. 2014-0002273 issued by Victoria Sto Domingo, Licensing Officer III certifying that IT Equipment is categorized as Office Equipment and that the said bidder has already presented all the necessary requirements needed in filing their Business Permit last April 14, 2014. Thus, the bidder was issued a Business Permit with validity period until December 31, 2014 under BIN 117-00-2004-000030724;

**WHEREAS**, Ng Khai Development Corporation likewise filed a response dated October 1, 2014 stating that certifying all Eligibility and Technical requirements as true and correct is sufficient to support the eligibility during the conduct of the bidding process;

**WHEREAS**, both Masangkay Computer Center and Ng Khai Development Corporation requested for PRO IX BAC to reconsider their appeal and grant them the approval to bid for the abovementioned project;
