

CONTRACT AGREEMENT FORM

THIS AGREEMENT made this 24th day of December 2014 between **PhilHealth Regional Office – CAR** represented by its Regional Vice President, **Atty. Jerry F. Ibay** (hereinafter called "the Entity") of the one part and **Philippine Long Distance Telephone Company** represented by its Vice President, **Mr. Renato L. Castañeda** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Proposals for the Negotiated Procurement of **Internet Service Provider** (hereinafter called "the Works") and has accepted a Proposal by the Supplier in the sum of **Two Hundred Fifteen Thousand and Forty Pesos (P215,040.00)** for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) The Bid Form
 - (b) Notice of Negotiated Procurement
 - (c) The Technical Specification
 - (d) The Notice of the Award
3. Effectivity period of the contract shall be on January 1, 2015 to December 31, 2016.
4. Monthly payment shall be in the amount of Eight Thousand Nine Hundred Sixty Pesos (P 8,960.00).
5. In consideration of the payments to be made by the Entity to the Supplier as aforementioned, the Supplier hereby covenants with the Entity to execute and complete the Works and remedy and defects therein in conformity in a respects with the provisions of the Contract.
6. The Entity hereby covenants to pay the Supplier the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed therein.


