RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING THE AWARD OF CONTRACT TO TRADE MASTER RESOURCES CORPORATION FOR THE PROCUREMENT OF AIR CONDITIONING UNITS FOR PHILHEALTH REGIONAL OFFICE 1 UNDER ITB NO. 2016-005

WHEREAS, the PhilHealth Regional Office 1-Bids and Awards Committee posted the Invitation to Bid for the Procurement of Air Conditioning Units under ITB No. 2016-005 with Total Approved Budget for the Contract (ABC) in the amount of One Million Two Hundred Forty Eight Thousand Nine Hundred Twenty Pesos (P1,248,920.00) in the Philippine Government Electronic Procurement System (PhilGEPS), Corporate Website, and conspicuous place of PRO 1 on May 27-June 2, 2016;

WHEREAS, in response to the said posting, the following four (4) prospective bidders purchased the bidding documents: K-Servico Trade, Inc., Lineaire Marketing and Airconditioning Services, NCO General Merchandise and Trademaster Resources Corporation;

WHEREAS, during the bid opening on June 21, 2016, the four (4) abovementioned bidders submitted bid proposals;

WHEREAS, the bid proposals of K-Servico and NCO General Merchandise were rated "failed" for non-compliance of the following:

WHEREAS, the bid proposals of Lineaire Marketing and Trademaster were found to be substantially complying and "Passed" the bid requirements;

WHEREAS, the bid of Trademaster was declared the lowest calculated bid with an amount of Nine Hundred Eighty Nine Thousand Pesos (P989,000.00);









WHEREAS, Trademaster underwent post-qualification conducted by the Technical Working Group on July 4-6, 2016,

WHEREAS, after careful validation, verification and detailed evaluation of the bids of Trademaster by the Technical Working Group, the team found Trademaster to have passed the criteria for post-qualification and is responsive to all the requirements and conditions for eligibility and the bidding of the contract as specified in the bidding documents;

WHEREAS, the bid submitted by Trademaster with an amount of Nine Hundred Eighty Nine Thousand Pesos (P989,000.00) was considered the Lowest Calculated and Responsive Bid;

WHEREAS, awarding the contract to Trademaster Resources Corporation for the Procurement of Air Conditioning Units would be advantageous and favorable on the part of the Corporation;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- 1) To declare the Lowest Calculated and Responsive Bid for the Procurement of Air-conditioning Units under ITB No. 2016-005;
- 2) To recommend the award of contract to Trademaster Resources Corporation;
- 3) To recommend for approval by the OIC, Regional Vice President, Head of the Procuring Entity of PhilHealth Regional Office I the foregoing findings.
