**RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID  
AND RECOMMENDING THE AWARD TO MASANGKAY COMPUTER CENTER  
FOR THE PROCUREMENT OF VARIOUS IT EQUIPMENT UNDER ITB NO. 2015-  
011 (LOT 2)**

**WHEREAS**, PhilHealth Regional Office 1-Bids and Awards Committee posted the Invitation to Bid for the Procurement of Various IT Equipment with Total Approved Budget for the Contract (ABC) in the amount of Eleven Million Six Hundred Ninety Five Thousand Pesos (P11,695,000.00) in the Philippine Government Electronic Procurement System (PhilGEPS), National Newspaper, Corporate Website, and conspicuous place of PRO 1 on December 28, 2015 to January 3, 2016;

**WHEREAS**, said project was posted in three (3) lots with ABCs amounting to: Lot 1- P7,700,000.00; Lot 2- P 3,455,000.00, Lot 3- P540,000.00;

**WHEREAS**, in response to the said posting, four (4) prospective bidders expressed their interest to join said bidding for:

**WHEREAS**, during the bid opening on January 22, 2016, two prospective bidders, Masangkay Computer Center (MCC) and DCI Int'l IT Solutions and Services Corp. submitted bid proposals for LOT 2;

**WHEREAS**, the bid proposals of MCC and DCI were found to be substantially complying and "Passed" the bid requirements;

**WHEREAS**, the bid of DCI Int'l was declared the Lowest Calculated Bid with an amount of Three Million Thirty Two Thousand Seven Hundred Nineteen and 75/100 Pesos (P3,032,719.75) which underwent post-qualification process on January 25-29, 2016;

**WHEREAS**, after careful validation, verification and detailed evaluation of the bids of DCI Int'l by the Provisional Member and Technical Working Group, the team found DCI Int'l to have failed the criteria for post-qualification on the following grounds:

- Non-compliance with the Technical Specifications of Printer- ID Badge, Network Switch-Layer 3 Switch, Manageable, and Scanner-Documnt Scanner, Auto documnt Feeder
- Non-submission of Certificate of Distributorship

**WHEREAS,** Masangkay Computer Center (MCC) underwent post-qualification as Next Lowest Calculated Bid on February 3-9, 2016;

**WHEREAS,** after careful validation, verification and detailed evaluation of the bids of MCC by the Provisional Member and Technical Working Group, the team found MCC to have passed the criteria for post-qualification and responsive to all the requirements and conditions for eligibility and the bidding of the contract as specified in the bidding documents;


**WHEREAS,** the bid submitted by MCC with an amount of Three Million Two Hundred Seventy Four Thousand Seven Hundred Seventy Four (P3,274,774.00) was considered the Lowest Calculated and Responsive Bid;

**WHEREAS,** awarding the contract to Masangkay Computer Center for the Procurement of Various IT Equipment (LOT 2) would be advantageous and favorable on the part of the Corporation;

**NOW, THEREFORE,** We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare the Lowest Calculated and Responsive Bid and recommend the award of contract to **Masangkay Computer Center for the Procurement of Various IT Equipment (LOT 2) under ITB No. 2015-011** for approval by the OIC, Regional Vice President, Head of the Procuring Entity of the PhilHealth Regional Office I the foregoing findings.
