PRO 1-BIDS AND AWARDS COMMITTEE **RESOLUTION NO. 047 s. 2016**

RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING THE AWARD OF CONTRACT TO PRECISION BLACK TONER, INC. FOR THE PROCUREMENT OF FIRST QUARTER IT SUPPLIES UNDER ITB NO. 2016-006

WHEREAS, the PhilHealth Regional Office 1-Bids and Awards Committee posted the Invitation to Bid for the Procurement of Air Conditioning Units under ITB No. 2016-005 with Total Approved Budget for the Contract (ABC) in the amount of One Million Two Hundred Ninety Eight Thousand Two Hundred Forty Six and 83/100 Pesos (P1,298,246.83) in the Philippine Government Electronic Procurement System (PhilGEPS), Corporate Website, and conspicuous place of PRO 1 on May 27-June 2, 2016;

WHEREAS, in response to the said posting, one prospective bidder Precision Black Toner, Inc. submitted bid proposal during the Bid Opening on June 21, 2016;

WHEREAS, the bid proposal of Precision Black Toner, Inc. was found to be substantially complying and "Passed" the bid requirements:

WHEREAS, the bid of Precision was declared the lowest calculated bid with an amount of Nine Hundred Ninety Seven Thousand Eight Hundred Sixty and 17/100 Pesos (P997,860.17);

WHEREAS, Precision underwent post-qualification conducted by the Technical Working Group on July 4-6, 2016,

WHEREAS, after careful validation, verification and detailed evaluation of the bid of Precision by the Technical Working Group, the team found Precision to have passed the criteria for post-qualification and is responsive to all the requirements and conditions for eligibility and the bidding of the contract as specified in the bidding documents;

WHEREAS, the bid submitted by Precision with an amount of Nine Hundred Ninety Seven Thousand Eight Hundred Sixty and 17/100 Pesos (P997,860.17) was considered the Lowest Calculated and Responsive Bid;

WHEREAS, awarding the contract to Precision Black Toner, Inc. for the Procurement of First Quarter IT Supplies would be advantageous and favorable on the part of the Corporation;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1) To declare the Lowest Calculated and Responsive Bid for the Procurement of 1st Quarter IT Supplies under ITB No. 2016-006;
