WHEREAS, PhilHealth Regional Office XI Bids and Awards Committee (BAC) advertised the Invitation to Apply for Eligibility and to Bid for the Procurement of I.T. Equipment (12 units Regular Laptop for PRO XI P-AIMS) and posted the same in the PHILHEALTH website, the G-EPS, and conspicuous place at Philhealth Regional Office XI Davao:

WHEREAS, in response to the said advertisements, the following bidders submitted to the BAC letters of intent and purchased bidding documents and application for eligibility, to wit: Columbia Computer Center Davao, Inc. and EMCOR, Inc.;
