**BAC RESOLUTION NO. 2016-06**

**BAC Resolution Recommending the Issuance of Notice of Award to Masangkay Computer for the Procurement of IT Equipment of PRO IV-B (Lot 1)**

WHEREAS, the Invitation to Bid for the Procurement of IT Equipment of PRO IV-B was posted in PhilGEPS, newspaper, bulletin board of PRO-IVB and corporate website of PhilHealth;

WHEREAS, Pre-bid conference was set last January 26, 2016 wherein two (2) prospective bidders attended the activity;

WHEREAS, Bid bulletin No. 2016-01 was issued last February 1, 2016 to effect minor changes in technical specifications of items;

WHEREAS, Bid opening was set last February 16, 2016 wherein, Masangkay Computer has submitted their bid proposal;

WHEREAS, bid proposal of Masangkay Computer has passed under the pass/fail criteria as read by the Chairperson and subsequently, their bid proposal amounting to P6,861,216.00 was declared within the ABC of the project;

WHEREAS, Masangkay Computer has been determined to be Single Calculated Bid after bid evaluation;

WHEREAS, Masangkay Computer submitted all the post-qualification requirements;

WHEREAS, Post Qualification results showed that Masangkay Computer did not comply with the Technical Specifications in one of the items for Lot 1;

WHEREAS, BAC on its meeting last March 18, 2016 disqualified the bid proposal of Masangkay Computer for failure to comply with the technical specifications of one of the items for Lot 1;

WHEREAS, BAC sent a letter of disqualification to the bidder informing of its decision;

WHEREAS, Masangkay Computer filed a motion for reconsideration within the prescribed period of filing;

WHEREAS, BAC on its meeting last April 6, 2016, agreed to grant the motion of Masangkay Computer and declared that the bid of the latter is qualified;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To recommend the issuance of Notice of Award to Masangkay Computer for the Procurement of IT Equipment for Lot 1;

WHEREAS, BAC on its meeting last April 6, 2016 discussed the appeal of Masangkay Computer;

WHEREAS, a motion was raised to hold the second demonstration of the equipment in order to render concrete decision on the appeal which was unanimously agreed by the members;

WHEREAS, notice was sent to the bidder informing of the BAC decision to hold the demonstration on April 7, 2016;

WHEREAS, Masangkay Computer replied through a letter that they cannot conduct the demonstration on the date scheduled by the BAC, instead, on April 11, 2016;

WHEREAS, BAC on its meeting last April 7, 2016 decided to give consideration on the request of Masangkay Computer and moved the demonstration on April 11, 2016;

WHEREAS, Masangkay Computer conducted the demonstration on the scheduled date witnessed by the BAC members and TWG member;




