

Contract Agreement Form

This Agreement made this 22ND day of FEBRUARY 2016 between **PHILHEALTH REGIONAL OFFICE NO. V** [*name of PROCURING ENTITY*] with office address at ANST Bldg. III, Alternate Road, Legazpi City and **3GX COMPUTER AND I.T. SOLUTIONS** [*name of Supplier*] with office address at # 3GX Solutions Bldg., Elias Angeles St., Dinaga, Naga City Camarines Sur

WHEREAS the Procuring Entity invited Bids on the **PROCUREMENT OF VARIOUS I.T. SUPPLIES** under Project Reference No. **PROV-2015 - 18** and has accepted a Bid by the Supplier, having been declared to be the lowest calculated and responsive bidder in the sum of **Nine Hundred Fourteen Thousand Eight Hundred Ninety Six pesos (P 914,896.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract;
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or

such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


5. The contracting parties undertake to comply with PhilHealth Office Order No. 0018-2015 entitled "Reiteration of PhilHealth No Gift Policy (Revision 1)" which is deemed incorporated into this Contract. *No PhilHealth personnel shall solicit, demand, or accept, directly or indirectly, any gift from any person, group, association, or juridical entity, whether from the public or private sector, at anytime, on or off the work premises where such gift is given in the course of official duties or in connection with any transaction which may affect the functions of their office or influence the actions of directors or employees, or create the appearance of a conflict of interest.*
