

CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT** made and entered into by and between:

PHILIPPINE HEALTH INSURANCE CORPORATION, a government owned and controlled corporation duly registered, organized and existing under Philippine laws with principal office at Citystate Centre Building, 709 Shaw Blvd., cor. Oranbo Drive, Pasig City, represented herein by **ATTY. KHALIQUZZAMAN M. MACABATO, CPA, CSEE.**, Regional Vice-President, PhilHealth Regional Office for the Autonomous Region in Muslim Mindanao (ARMM), with office address at Al-bani Bldg., Osmeña Street, Marawi City, pursuant to *PhilHealth Board Resolution No. 731, s. 2004 and Office Order No. 0139, s. 2004*, herein referred to as the **"FIRST PARTY"**.

GRAND ASTORIA HOTEL, a duly registered establishment engaged in Hotel, restaurant and catering services, herein represented by **MS. JANE SANTIAGO**, Executive Officer, with business address at Mayor Jaldon Street, 7000, Zamboanga City, as hereinafter referred to as the **"SECOND PARTY"**

-Witnesseth-

WHEREAS, the First Party needs to lease a venue for the holding of REACHOUT Forum 2016 in Zamboanga City for accredited Health Care Professionals (HCPs) residing and stationed in Basilan, Sulu and Tawi-Tawi on May 26, 2016;

WHEREAS, the Second Party is engaged in the business of hotel, restaurant, and catering services that offers its service to the public situated in Mayor Jaldon Street, 7000, Zamboanga City;

WHEREAS, after conduct of Negotiated Procurement for Lease of Privately-Owned Venue, pursuant to the revised IRR of R.A. No. 9184 and Office Order No. 044-2015 (Guidelines for Conduct of Negotiated Procurement – Lease of Privately-Owned Venue), First Party awarded the contract to the Second Party for the conduct of Quality Management System Seminar Orientation for Parang and Buluan Personnel;

WHEREAS, the Second Party binds itself to provide the needs of the First Party for the said activity;

NOW, THEREFORE, for and in consideration of the foregoing stipulations, the Second Party hereby accepts to lease its establishment for venue of the seminar, meals and accommodation of participants to the First Party for the Conduct of REACHOUT Forum 2016 on May 26, 2016, subject to the following terms and conditions, to wit:

1. That Second Party will ensure availability of the venue for the use of the Second Party on the date/s stated above;
2. The Second Party shall provide meals, consisting of lunch, morning snack and afternoon snack, for One Hundred Twenty Six (126)

3. The First Party shall pay the amount of **Forty Seven Thousand Eight Hundred Eighty Pesos (P 47,880.00)**, inclusive of taxes and other charges;
4. That the Second Party offers the use of Function Room for free or at no cost;
5. That, preferably, the First Party shall pay the Second Party after completion of the activity subject to usual accounting and auditing rules and regulations;
6. That the Billing Statement/statement of account shall be issued by the Second Party upon completion of the activity;
7. That the First Party shall pay in the form of Check issued and drawn in the name of the Second Party;
8. That either of parties hereto may terminate this contract without a cause provided that a notice shall be issued thirty (30) days prior to the intended date of termination.
