**BAC Resolution Recommending Award of Contract to GRAND

**RESOLUTION No. V-16-007**

**WHEREAS**, *Republic Act No. 9184*, otherwise known as the Government Procurement Reform Act, and its Implementing Rules and Regulations (IRR) prescribes and governs the mode, process and procedure of procurement of goods, infrastructure and consultancy services. *Section 53.10 of the revised IRR of R.A. No. 9184* provides that Lease of Privately Owned Venue shall be conducted through Negotiated Procurement. By virtue of this provision, *GPPB Resolution No. 08-2009* dated November 3, 2009 was issued providing for the Implementing Guideline for Lease of Privately-Owned Real Estate and Venue. Pursuant to this mandate, Philhealth adopted and issued *Office Order No. 44-2015* providing for the Guidelines and Procedures on Conduct of Negotiated Procurement – Lease of Privately-Owned Venue;

**WHEREAS**, upon evaluation and assessment of the Cost-Benefit Analysis (CBA) undertaken by the Health Care Delivery Management Division (HCDMD), as end-user, for the conduct of **REACHOUT Forum 2016 on May 26, 2016**, the BAC Secretariat submitted the recommendation to be responsive and reasonable. Further, the quotation price offered by the supplier is within the Approved Budget for the Contract (ABC) and the same is economical and advantageous to the Corporation;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee (BAC), hereby RESOLVE as it is hereby RESOLVED to recommend the awarding of the contract for lease of venue for the conduct of **REACHOUT Forum 2016 on May 26, 2016** to **GRAND ASTORIA HOTEL** with business address at Mayor Jaldon St., Zamboanga City;
