

## Contract Agreement Form

THIS AGREEMENT made this 22<sup>nd</sup> day of February 2016 between **PhilHealth Regional Office - CAR** (hereinafter called "the Entity") of the one part and **E-PLDT, Inc.** represented by its Relationship Manager, **Mr. Louie M. Metra** (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for the **Procurement of 1 Lot Network Devices** (hereinafter called "the Works") and has accepted a Bid by the Supplier in the sum of **Nine Hundred Ninety Two Thousand Thirty Seven and 76/100 (P 992,037.76)** (hereinafter called "the Contract Price") for the execution and completion of such Works and the remedying of any defects therein.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Bid Form and the Price Schedule submitted by the Bidder;
  - (b) the Invitation to Bid
  - (c) the Supplemental Bid Bulletin
  - (d) the General Condition of Contract
  - (e) the Special Conditions of Contract
  - (f) the Schedule of Requirements
  - (g) the Technical Specification
  - (h) the Notice of Award
  - (i) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration of the payments to be made by the Entity to the Supplier as aforementioned, the Supplier hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed therein.




