## PRO-BAC RESOLUTION NO.017 s.2019

RESOLUTION TO DECLARE THE BID OF LUCENA GRAND CENTRAL TERMINAL INC. (LGCTI) AS SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDS THE AWARDING OF CONTRACT FOR THE PROVISION OF SIX (6) MONTHS RENTAL CONTRACT FOR STORAGE SPACE OF PHILHEALTH REGIONAL OFFICE IVA (PRO IVA) MAIN OFFICE PER INP#2019-LRP-01
