RESOLUTION NO. 52, S-2019

RESOLUTION RECOMMENDING TO THE VICE PRESIDENT OF PHILHEALTH REGIONAL OFFICE NATIONAL CAPITAL REGION (PRO NCR) AS HEAD OF THE PROCURING ENTITY, THAT THE LEASE OF VENUE FOR THE CONDUCT OF PRO NCR COLLECTING OFFICERS CONFERENCE FOR CY2019 BE AWARDED TO ARANETA HOTELS INC. (NOVOTEL MANILA ARANETA CENTER) BEING THE LOWEST CALCULATED AND RESPONSIVE QUOTATION, PURSUANT TO SECTION 53.10 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184 -LEASE OF PRIVATELY OWNED REAL PROPERTY AND VENUE.

WHEREAS, the said event is included in the Annual Procurement Plan for CY2019 under Corporate Forum via Negotiated Procurement - Lease of Real Property and Venue;

WHEREAS, based on the Abstract of Canvass prepared by the End-User, Novotel Hotel submitted the lowest price quotation, is available on the date of the event, complied with the venue requirements of end-user and documentary requirement, and it is within the Approved Budget for the Contract. The Sulo Riviera Hotel submitted the second lowest price quotation. Sequoia Hotel submitted the highest price quotation and exceeded the Approved Budget for the Contract;

WHEREAS, the end-user certified that there is no government venue available and compliant with the technical specification;

WHEREAS, considering the price quotation submitted and the responsiveness of the venue as determined by the End User, Novotel Manila Araneta Center was then found to be the lowest calculated and responsive quotation with passing rate 95.05%;

NOW, THEREFORE, premises considered, the PRO NCR BAC resolves, to recommend to the Vice President of the Philhealth Regional Office - NCR (PRO NCR), as Head of the Procuring Entity, that the Lease of Venue for the conduct of PRO NCR Collecting Officers for CY2019 on October 28-29, 2019 be awarded to ARANETA HOTELS INC. (NOVOTEL MANILA ARANETA CENTER) at One Hundred Twenty Thousand Pesos (Php120,000.00) for having been determined as the Lowest Calculated and Responsive Quotation, pursuant to Section 53.10 of Revised Implementing Rules and Regulations of RA 9184 – Lease of Privately Owned Real Property and Venue.
