RESOLUTION NO. 14, S-2019

RESOLUTION RECOMMENDING TO THE VICE PRESIDENT OF PHILHEALTH REGIONAL OFFICE NATIONAL CAPITAL REGION (PRO NCR) AS HEAD OF THE PROCURING ENTITY, THAT THE LEASE OF VENUE FOR THE CONDUCT OF PRO NCR'S EMPLOYEE ORIENTATION FOR THE NEWLY APPOINTED PERSONNEL BE AWARDED TO NORTHBELLE PROPERTIES INC. (B HOTEL) BEING THE LOWEST CALCULATED AND RESPONSIVE QUOTATION, PURSUANT TO SECTION 53.10 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184 – LEASE OF PRIVATELY OWNED REAL PROPERTY AND VENUE.

WHEREAS, on April 30, 2019, the following documents for the conduct of PRO NCR's employee orientation for the newly appointed personnel with an Approved Budget for the Contract of Sixty Three Thousand Pesos (Php63,000.00) for the venue and meals of the participants per CPO PRO NCR No. 2019-191, certified as funded in the COB 2019 by the Fund Management Section, were submitted to the Bids and Awards Committee (BAC) for its perusal, viz:

- 3. Quotation, Factor Rating and Documentary Requirements from B Hotel
- 4. Quotation from Novotel Hotel & Resorts
- 5. Ouotation from Luxent Hotel
- 6. Certification from UP School of Labor and Industrial Relations
- 7. Technical Specification for the Lease of Venue
- 8. Approved Request for the conduct of Training/Forum
- 9. Purchase Request
- 10. Approved Budget for the Contract and Matrix of Canvass
- 11. Approved Project Proposal for the conduct of PRO NCR's Employee Orientation for the Newly Appointed Personnel
- 12. Corporate Personnel Order PRO NCR No. 2019-119
- 13. Approved PPMP and Budget Release Order NCR-19-059-05

WHEREAS, the said corporate forum is included in the Annual Procurement Plan for via Negotiated Procurement – Lease of Real Property and Venue;

WHEREAS, based on the 2016 Revised IRR of RA 9184, request for quotation must be sent to at least three (3) venues within the vicinity of the selected location. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, based on the documents submitted by the End User, two (2) prospective private venues submitted their quotation for the said event, namely:

WHEREAS, based on the Abstract of Canvass prepared by the End-User, B Hotel submitted the lowest price quotation, complied with all the venue requirements of end-user, it is within the Approved Budget for the Contract, available on the date of the event, and complied with the documentary requirement. Novotel Hotel and Resorts submitted the highest price quotation and exceeded the Approved Budget for the Contract. Luxent Hotel submitted their general proposal, however, they no longer have available function room on the date of the event;

WHEREAS, UP School of Labor and Industrial Relations, a government facility, certify that they cannot accommodate the request of end-user to use the venue for the said event;

WHEREAS, considering the price quotation submitted and the responsiveness of the venue as determined by the End User, B Hotel was then found to be the lowest calculated and responsive quotation with passing rate 99.5%;

NOW, THEREFORE, premises considered, the PRO NCR BAC resolves, to recommend to the Vice President of the Philhealth Regional Office - NCR (PRO NCR), as Head of the Procuring Entity, that the Lease of Venue for the conduct of PRO NCR's Employee Orientation for the Newly Appointed Personnel be awarded to NORTHBELLE PROPERTIES INC. (B HOTEL) at Sixty Thousand Pesos (Php60,000.00) for having been determined as the Lowest Calculated and Responsive Quotation, pursuant to Section 53.10 of Revised Implementing Rules and Regulations of RA 9184 - Lease of Privately Owned Real Property and Venue.
