RESOLUTION NO. 107, S-2019

RESOLUTION RECOMMENDING TO THE VICE PRESIDENT OF PHILHEALTH REGIONAL OFFICE NATIONAL CAPITAL REGION (PRO NCR) AS HEAD OF THE PROCURING ENTITY, THAT THE LEASE OF VENUE FOR THE CONDUCT OF PRO NCR'S GENDER SENSITIVITY TRAINING BE AWARDED TO NORTHBELLE PROPERTIES INC. (B HOTEL) BEING THE LOWEST CALCULATED AND RESPONSIVE QUOTATION, PURSUANT TO SECTION 53.10 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF R.A. 9184 – LEASE OF PRIVATELY OWNED REAL PROPERTY AND VENUE.

WHEREAS, on October 31, 2019, the following documents for the conduct of PRO NCR's Gender Sensitivity Training on November 22, 2019 with an Approved Budget for the Contract of Seventy Nine Thousand Three Hundred Eighty Pesos only (Php79,380.00) for the venue and meals of the participants per CPO PRO NCR No. 2019-790, certified as funded in the COB 2019 by the Fund Management Section, were submitted to the Bids and Awards Committee (BAC) for its perusal, viz:

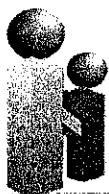

WHEREAS, the said event is included in the Amendment of APP for CY2019 via Negotiated Procurement – Lease of Real Property and Venue;

WHEREAS, based on the 2016 Revised IRR of RA 9184, request for quotation must be sent to at least three (3) venues within the vicinity of the selected location. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;

WHEREAS, based on the Abstract of Canvass prepared by the End-User, B Hotel submitted the lowest price quotation, complied with the venue requirements of end-user and documentary requirements, and it is within the Approved Budget for the Contract. Novotel Hotel submitted the second lowest price quotation and Seda Vertis North submitted the highest price quotation and both exceeded the Approved Budget and on waitlisted;

WHEREAS, UP School of Labor & Industrial Relations, a government facility, certified that most of the rooms are being occupied by the School of Information and Library Science and it is currently unavailable;


WHEREAS, the end-user certified that Office of the Vice President, PRO NCR has no appropriate venue for the said event and UP School of Labor & Industrial Relations has no available and adequate facility for the said event;

WHEREAS, considering the price quotation submitted and the responsiveness of the venue as determined by the End User, B Hotel was then found to be the lowest calculated and responsive quotation with passing rate 99.50%;

NOW, THEREFORE, premises considered, the PRO NCR BAC resolves, to recommend to the Vice President of the Philhealth Regional Office – NCR (PRO NCR), as Head of the Procuring Entity, that the Lease of Venue for PRO NCR's conduct of Gender Sensitivity Training on November 22, 2019 be awarded to **NORTHBELLE PROPERTIES INC. (B HOTEL)** at Seventy Five Thousand Six Hundred Pesos (Php75,600.00) for having been determined as the Lowest Calculated and Responsive Quotation, pursuant to Section 53.10 of Revised Implementing Rules and Regulations of RA 9184 – Lease of Privately Owned Real Property and Venue.
