WHEREAS, an Invitation to Bid was posted from 11 March 2019 to 10 April 2019 and the Pre Bid Conference was scheduled on 19 March 2019;

WHEREAS, the following proponents: Project Management & Technical Resources Corp., Progress Home & Office Furnioshings, and Design Excellence Home & Office Systems Co. attended the Pre-Bid Conference on 19 March 2019;

WHEREAS, during the Opening of Bids and Eligibility Check on 10 April 2019, the company Project Management & Technical Resources Corp. was the only proponent bought and submitted the Bid Documents and was likewise, declared the Single Calculated Bid with an offer of Three Million Seven Hundred Sixty Eight Thousand Pesos (Php 3,768,000.00) for the Procurement of One (1) Lot Supply and Installation of Multi-Tier Racking System for PRO NCR;

WHEREAS, the Bids and Awards Committee directed the Technical Working Group (TWG) A to immediately conduct the Post Qualification and Evaluation activity for PROJECT MANAGEMENT & TECHNICAL RESOURCES CORP. being the Single Calculated Bid;
