

CONTRACT AGREEMENT
FOR MOTORPOOL SERVICES

THIS AGREEMENT made on the _____ day of MAR 17 2020 2020 between **PHILIPPINE HEALTH INSURANCE CORPORATION**, a government-owned and controlled corporation created and existing by virtue of R.A. 7875, as amended, otherwise known as the National Health Insurance Act”, with regional office address at Lucena Grand Central Terminal, Brgy. Ilayang Dupay, Lucena City, represented herein by its **Regional Vice President, EDWIN M. ORIÑA, M.D.** (hereinafter called “the Entity”)

-and-

MILLENIUM TIRE CHECK CENTER, a sole proprietorship duly registered with Department of Trade and Industry (DTI) and existing under the laws of the Republic of the Philippines with business address at **Diversion Road, Domoit**, Lucena City, represented herein by its **Proprietor, MICHAEL JOHN CHING TAN** (hereinafter called “the Supplier”):

WHEREAS, the Entity invited Bids for the **Motorpool Services** and has accepted the Bid of the **Supplier**, for the supply of goods and services in the sum of **One Hundred Eighty-Eight Thousand Four Hundred Pesos or ₱188,400.00** (hereinafter called “Contract Price”).

WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The Supplier’s Bid or filled-out Request for Quotation shall form and be read and construed as part of this Agreement.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein the Contract Price in the manner prescribed by the contract.
5. The contract price covers the costs of all Deliverables Items and Services and includes all applicable taxes, including the 12% Value-Added-Tax, customs duties, license fees, freight, insurance, cost of importation, transportation and delivery at the time and locations specified and other charges which may be imposed on the Product by foreign and local authorities.
6. The Supplier hereby covenants to deliver in favor of the Entity the Motorpool Services and the services related hereto, in accordance with the technical specifications as stated in Annex “A” of this contract.
7. The Entity shall pay the Supplier for each service rendered and accepted by the Entity within ten (10) working days upon submission of the Supplier of the **STATEMENT OF BILLING ACCOUNT** and other documentary requirements as may be required by the Entity as condition for payment, provided that the same has been verified to be correct by the Entity.
8. Both parties hereby warrant that they have the authority and capacity to enter and sign in this contract.
9. All other terms, conditions and stipulations accompanying this Contract together with all proposals and all mandatory provisions of the 2016 Revised Implementing Rules and Regulations of R.A. No. 9184, shall form as integral parts of this contract between the **PARTIES** hereto.

The parties hereby certify that they have read or caused to be read to them each and every provision of this Contract and that they have fully understood the same.






