

**CONTRACT AGREEMENT
FOR PERIODIC HEALTH EXAMINATION OF
PRO IVA, CAVITE LHIOs EMPLOYEES FOR CY 2021**

THIS **CONTRACT** made on the _____ day of _____ 2021 between **PHILIPPINE HEALTH INSURANCE CORPORATION**, a government-owned and controlled corporation created and existing by virtue of R.A. 7875, as amended, otherwise known as the National Health Insurance Act”, with regional office address at Lucena Grand Central Terminal, Brgy. Ilayang Dupay, Lucena City, represented herein by its **Acting Regional Vice-President, ARLAN M. GRANALI** (hereinafter called “**PHILHEALTH**”)

-and-

EMILIO AGUINALDO COLLEGE MEDICAL CENTER, a corporation duly registered with Securities and Exchange Commission (SEC) and existing under the laws of the Republic of the Philippines with business address at **Brgy. Salitran II, Dasmariñas City, Cavite**, represented herein by its **Hospital Director, GENALIN P. TRIAS, MD.** (hereinafter called “**EAC MEDICAL CENTER**”):

WHEREAS, **PHILHEALTH** invited Bids for the **Procurement of Periodic Health Examination for PRO IVA, Cavite LHIOs Employees for CY 2021** and has accepted the Bid by **EAC MEDICAL CENTER**, for the provision of said services in the sum of **ONE HUNDRED TWO THOUSAND FIFTY FIVE PESOS ONLY (₱ 102,055.00)** (hereinafter called “**Contract Price**”).

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereto have agreed as they hereby agree and bind themselves as follows:

1. In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereunder referred to.
2. The Supplier’s Bid or filled-out Request for Quotation and Statement of Compliance shall form and be read and construed as part of this Agreement.
3. In consideration of the payments to be made by **PHILHEALTH** to **EAC MEDICAL CENTER** as hereinafter mentioned, **EAC MEDICAL CENTER** hereby covenants with **PHILHEALTH** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of this Contract.
4. **PHILHEALTH** hereby covenants to pay **EAC MEDICAL CENTER** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price at the time and in the manner prescribed by this contract.
5. The contract price covers the costs of all Deliverables Items and Services and includes all applicable taxes, including the 12% Value-Added-Tax, customs duties, license fees, freight, insurance, cost of importation, transportation and delivery at the time and locations specified and other charges which may be imposed on the Product by foreign and local authorities.
6. **EAC MEDICAL CENTER** hereby covenants to deliver in favor of **PHILHEALTH** the **Procurement of Periodic Health Examination for PRO IVA Employees, Cavite LHIOs for CY 2021** and the services related hereto, in accordance with the technical specifications as stated in the Annexes of this contract.
7. Contract duration is sixty (60) sixty calendar days and will start from the issuance of Notice to Proceed by **PHILHEALTH**.
8. **PHILHEALTH** shall remit **EAC MEDICAL CENTER** the payment for expenses incurred by its employees based on the **ACTUAL SERVICES** rendered to **PHILHEALTH’s** employees within thirty (30) working days from receipt of respective billing statements, provided that the corresponding bookbind of the alphabetically ordered summarized list of the examination results and

The parties hereby certify that they have read or caused to be read to them each and every provision of this Contract and that they have fully understood the same.


