

CONTRACT AGREEMENT
FOR PREVENTIVE MAINTENANCE SERVICES OF
LHIO SAN PABLO MOTOR VEHICLE

THIS AGREEMENT made on the _____ day of APR 13 2021 2021
between PHILIPPINE HEALTH INSURANCE CORPORATION, a government-owned
and controlled corporation created and existing by virtue of R.A. 7875, as amended,
otherwise known as the "National Health Insurance Act", with regional office address at
Lucena Grand Central Terminal, Brgy. Ilayang Dupay, Lucena City, represented herein
by its Acting Regional Vice President, ARLAN M. GRANALI (hereinafter called "the
entity")

-and-

GENCARS SAN PABLO INC, a corporation duly registered with Department of Trade
and Industry (DTI) and existing under the laws of the Republic of the Philippines with
business address at Colago Ave. Brgy. I-A, San Pablo City, represented herein by its
Service Manager, JERRY D. MOLO (hereinafter called "the supplier"):

WHEREAS, the Entity invited Bids for the Motorpool Services and has accepted
the Bid of the Supplier, for the supply of goods and services in the sum of Twenty Five
Thousand Six Hundred Eighty Three Pesos or P 25, 683.00 (hereinafter called "Contract
Price").

WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meaning as are
respectively assigned to them in the Conditions of Contract referred to.
2. The Supplier's Bid or filled-out Request for Quotation shall form and be read and
constructed as part of this Agreement.
3. In consideration of the payments to be made by the Entity to the Supplier as
hereinafter mentioned, the Supplier hereby covenants with the Entity to provide
the goods and services and to remedy defects therein in conformity in all
respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision
of the goods and services and the remedying of defects therein the Contract
Price in the manner prescribed by the contract.
5. The contract price covers the costs of all Deliverables Items and Services and
includes all applicable taxes, including the 12% Value-Added-Tax, customs
duties, license fees, freight, insurance, costs of importation, transportation and
delivery at the time and locations specified and other charges which may be
imposed on the Product by foreign and local authorities.
6. The Supplier hereby covenants to deliver in favor of the Entity the Preventive
Maintenance Services and the services related hereto, in accordance with the
technical specifications as stated in Annex "A" of this contract.
7. The Entity shall pay the Supplier for each service rendered and accepted by the
Entity within ten (10) working days upon submission of the Supplier of the
STATEMENT OF BILLING ACCOUNT and other documentary requirements as
may be required by the Entity as condition for payment, provided that the same
has been verified to be correct by the Entity. Contract duration starts within one
(1) day from receipt of Notice to Proceed by the Supplier and ends by December
31, 2021 or upon consumption of contract amount whichever may come first.
8. Both parties hereby warrant that they have the authority and capacity to enter and
sign in this contract.
9. All other terms, conditions and stipulations accompanying this Contract together
with all proposals and all mandatory provisions of the 2016 Revised
Implementing Rules and Regulations of R.A. No. 9184, shall form as integral
parts of this contract between the PARTIES hereto.






