WHEREAS, PHILHEALTH invited Bids for the Oral and Written Communication Skills Training nd has accepted the Bid by "POAP", for the training fee in the sum of FIFTY THOUSAND PESOS Php 50,000.00) (hereinafter called "Contract Price").

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereto have greed as they hereby agree and bind themselves as follows:

- In this Contract, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract hereunder referred to.
- The following documents shall form and be read and construed as part of this Agreement, viz.:

In consideration of the payments to be made by PHILHEALTH to PERSONNEL OFFICERS ASSOCIATION OF THE PHILIPPINES, INC. as hereinafter mentioned, POAP hereby covenants with PHILHEALTH to provide the training services and to remedy defects therein in conformity in all respects with the provisions of this Contract.

PHILHEALTH hereby covenants to pay PERSONNEL OFFICERS ASSOCIATION OF THE PHILIPPINES, INC. in consideration of the provision of the training services and the remedying of defects therein, the Contract Price at the time and in the manner prescribed by this contract.

- The contract price covers the costs of all Services and includes all applicable taxes, including the 12% Value-Added-Tax, customs duties, license fees, freight, insurance, cost of importation, transportation and delivery at the time and locations specified and other charges which may be imposed on the Product by foreign and local authorities.

- All other terms, conditions and stipulations accompanying this Contract together with all proposals and all mandatory provisions of the Revised Implementing Rules and Regulations of R.A. No. 9184, shall form as integral parts of this contract between the PARTIES hereto.
