

CONTRACT FOR THE
ORAL AND WRITTEN COMMUNICATION SKILLS TRAINING

THIS CONTRACT made on the _____ day of _____ 2021 between
PHILIPPINE HEALTH INSURANCE CORPORATION, a government-owned and controlled
corporation created and existing by virtue of R.A. 7875, as amended, otherwise known as the National Health
Insurance Act”, with office address at Lucena Grand Central Terminal, Brgy. Ilayang Dupay, Lucena City,
represented herein by its **Acting Regional Vice-President, ARLAN M. GRANALI** (hereinafter called
“**PHILHEALTH**”)

-and-

PERSONNEL OFFICERS ASSOCIATION OF THE PHILIPPINES, INC., a corporation
fully registered with the Securities and Exchange Commission and existing under the laws of the Republic of
the Philippines with business address at **9 Biscayne Street, South Fairview, Brgy Fairview Park, Quezon
City 118**, represented herein by its **Representative, LORETA G. AYSON** (hereinafter called “**POAP**”):

WHEREAS, PHILHEALTH invited Bids for the **Oral and Written Communication Skills Training**
and has accepted the Bid by “**POAP**”, for the training fee in the sum of **FIFTY THOUSAND PESOS
Php 50,000.00** (hereinafter called “**Contract Price**”).

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereto have
agreed as they hereby agree and bind themselves as follows:

In this Contract, words and expressions shall have the same meaning as are respectively assigned to
them in the Conditions of Contract hereunder referred to.

The following documents shall form and be read and construed as part of this Agreement, viz.:

- (a) POAP Bid, including the Terms of Reference (**Annex "A"**)

In consideration of the payments to be made by **PHILHEALTH** to **PERSONNEL OFFICERS
ASSOCIATION OF THE PHILIPPINES, INC.** as hereinafter mentioned, **POAP** hereby
covenants with **PHILHEALTH** to provide the training services and to remedy defects therein in
conformity in all respects with the provisions of this Contract.

PHILHEALTH hereby covenants to pay **PERSONNEL OFFICERS ASSOCIATION OF
THE PHILIPPINES, INC.** in consideration of the provision of the training services and the
remedying of defects therein, the Contract Price at the time and in the manner prescribed by this
contract.

The contract price covers the costs of all Services and includes all applicable taxes, including the 12%
Value-Added-Tax, customs duties, license fees, freight, insurance, cost of importation, transportation
and delivery at the time and locations specified and other charges which may be imposed on the
Product by foreign and local authorities.

PERSONNEL OFFICERS ASSOCIATION OF THE PHILIPPINES, INC. hereby
covenants to deliver in favor of **PHILHEALTH** the **Oral and Written Communication Skills
Training** and the services related hereto, in accordance with the technical specifications as stated in
the Annexes of this contract.

Within Forty Five (45) days after complete delivery to and acceptance by **PHILHEALTH** and upon
submission of **PERSONNEL OFFICERS ASSOCIATION OF THE PHILIPPINES, INC.** of
the **STATEMENT OF BILLING ACCOUNT** and other documentary requirements as may be
required by **PHILHEALTH** as condition for payment, the latter shall pay the sum of **FIFTY
THOUSAND PESOS (Php 50,000.00) only**, which is one hundred percent (100%) of the total
contract price.

All other terms, conditions and stipulations accompanying this Contract together with all proposals
and all mandatory provisions of the Revised Implementing Rules and Regulations of R.A. No. 9184,
shall form as integral parts of this contract between the **PARTIES** hereto.
