**RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY,
THE AWARD OF CONTRACT TO MASADA SECURITY AGENCY, INC. FOR THE
PROCUREMENT OF SECURITY SERVICE FOR PRO NCR (PRO NCR ITB NO.
02, 2021 SECURITYSERVICE)**

WHEREAS, on April 30, 2021, the end-user submitted documents for the Procurement of Security Services for PRO NCR with an Approved Budget for the Contract (ABC) of One Hundred Sixty Million Six Hundred Seven Thousand Three Pesos and 24/100 (Php160,607,003.24) for three years or Fifty Three Million Five Hundred Thirty Five Thousand Six Hundred Sixty Seven Pesos and 75/100 (Php53,535,667.75) per year;

WHEREAS, upon its endorsement to the Bids and Awards Committee (BAC) for the PhilHealth Regional Office – National Capital Region, the following documents were attached for its perusal, viz:

3. Approved Budget for the Contract
4. Approved Terms of Reference

6. Abstract of Canvass
7. Initial Canvass Quotations from
 - a. Masada Security Agency Inc.

WHEREAS, on 07 May 2021, Pre-Procurement Conference was held where the Terms of Reference and completeness of documents has been checked and calendar of activities for the Procurement of Security Services has been set;

WHEREAS, the invitation to bid was posted in PhilHealth Website, PhilGeps and conspicuous places from 12 May to 02 June 2021;

WHEREAS, Commission on Audit, Philippine Chamber of Commerce and Industry, and Knight of Kolumbus of Fraternal Association of the Philippines has been invited to sit as observers during the procurement process;

WHEREAS, on 19 May 2021, during the Pre-Bid Conference, a representative from Grand Meritus Security Agency, Inc. attended physically, and representative from Masada Security

Agency and Northcom Security and Investigation Agency attended virtually, and raised issues and concerns for the procurement of Security Service of PRO NCR;

WHEREAS, a Supplemental Bid Bulletin was issued and posted on 26 May 2021 based on the agreement made during the Pre-Bid Conference;

WHEREAS, another Supplemental Bid Bulletin was issued and posted on 02 June 2021 based on the changes made on 01 June 2021, including the change of date for the opening of bids;

WHEREAS, during the Opening of Bids and Eligibility Check on 10 June 2021, only two (2) proponents bought and submitted the bidding documents namely:

WHEREAS, Masada Security Agency, Inc. was declared the Lowest Calculated Bid with and offer of Forty Two Million Six Hundred Eighty Two Thousand Eight Hundred Fifty Two Pesos and 68/100 for the Procurement of Security Services for PRO NCR. The Bids and Awards Committee directed the Technical Working Group (TWG) to immediately conduct the Post Qualification and Evaluation;

WHEREAS, on 21 – 22 June 2021, the Technical Working Group conducted the Post Qualification and Evaluation for Masada Security Agency, Inc.;

WHEREAS, on 23 June 2021, the Vice-Chairperson of Technical Working Group, presented their Post Qualification and Evaluation Report dated June 22, 2021 to the Bids and Awards Committee. Based on their evaluation, MASADA SECURITY AGENCY, INC., has **PASSED** the Technical, Financial and Post Qualification requirements for the Procurement of Security Services for PRO NCR, hence found to be **RESPONSIVE**;

RESOLUTION

WHEREFORE, in view of the foregoing, the BAC PRO NCR resolves to recommend to the Vice President of Area II and concurrent Vice President of PRO NCR as the Head of the Procuring Entity (HoPE) the award of the contract to **MASADA SECURITY AGENCY, INC.** at Forty Two Million Six Hundred Eighty Two Thousand Eight Hundred Fifty Two Pesos and 68/100 (Php42,682,852.68) being the Lowest Calculated and Responsive Bid (LCRB) for the Procurement of Security Services for PRO NCR.
