

**CONTRACT ON THE RE-BIDDING FOR THE  
PROCUREMENT OF EQUIPMENT FOR EMERGENCY AND DISASTER  
PREPAREDNESS - AUTOMATED EXTERNAL DEFIBRILLATOR (AED) SET  
(IB No. RAED 2022-05-AA)**

THIS AGREEMENT made and entered into this NOV 14 2022 day of NOVEMBER 2022, in the City of MANILA, Metro Manila, by and between:

**PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH)**, a government owned and controlled corporation duly organized and existing by virtue of Republic Act No. (RA) 7875, otherwise known as the "National Health Insurance Act", as amended by RA 9241 and RA 10606, with principal office address at 17<sup>th</sup> Floor, Citystate Centre Bldg., 709 Shaw Blvd. corner Oranbo Drive, Pasig City, represented herein by its Officer-in-Charge, Office of the President and Chief Executive Officer (CEO), **ATTY. ELI DINO D. SANTOS**, duly authorized to enter into this Contract, as evidenced by Secretary's Certificate, which is attached hereto as Annex "A", hereinafter referred to as the "**PHILHEALTH**";

**INTELLISERVE TRADING INCORPORATED**, a stock corporation, duly organized and existing under and by virtue of Philippine laws, and registered with the Securities and Exchange Commission, with principal office address at Unit 615 Globe Telecom Plaza 1, Pioneer St. Corner Madison St. Mandaluyong City, **JAYNE DELA CRUZ TADEO**, duly authorized to enter into this Contract, as evidenced by Secretary's Certificate dated June 16, 2022, which is attached hereto as Annex "B", hereinafter referred to as "**INTELLISERVE**";

**WHEREAS, PHILHEALTH** invited Bids for certain goods and ancillary services particularly on the **Procurement of Equipment for Emergency and Disaster Preparedness - Automated External Defibrillator (AED) Set** and has accepted a Bid by **INTELLISERVE** for the supply of those goods and services in the sum of, **THREE MILLION EIGHT HUNDRED EIGHTY-EIGHT THOUSAND PESOS (PhP3,888,000.00)** (hereinafter called "**the Contract Price**").


**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.


- (f) Notice of Award of Contract and the Bidder's conforme thereto (**Annex "G"**);

- (g) Other contract document that may be required by existing laws and/or the **PHILHEALTH** in the PBDs. **INTELLISERVE** agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **THREE MILLION EIGHT HUNDRED EIGHTY-EIGHT THOUSAND PESOS (PhP3,888,000.00)** or such other sums as may be ascertained, **INTELLISERVE** agrees to provide the goods and services and to remedy defects therein within the warranty period in accordance with its Bid.
4. **PHILHEALTH** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
