CONTRACT ON THE BIDDING FOR THE PROCUREMENT OF VARIOUS SUPPLIES FOR **HEALTH AND MEDICAL EMERGENCIES** (IB No. VSHME 2021-009-AC)

THIS AGREEMENT made and entered into this City of TAGUIG CI Metro Manila, by and between:

PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), a government owned and controlled corporation duly created by virtue of R.A. 7875, as amended by R.A. 9241 and R.A. No. 10606 or the "National Health Insurance Act of 2013", with principal office address at 17th Floor, Citystate Centre Building, 709 Shaw Blvd corner Oranbo Drive, Pasig City. PHILHEALTH is represented in this Agreement by its Officer-in-Charge, Office of the President and Chief Executive Officer (CEO), ATTY. ELI DINO D. SANTOS who is authorized to sign this agreement under PhilHealth Secretary's Certificate, copy attached hereto as Annex "A";

-and-

ORDENT TRADING CORP., a stock corporation, organized and registered with the Securities and Exchange Commission and existing under the laws of the Republic of the Philippines, with business address at Unit LG12 Cityland Shaw Tower, Shaw Blvd. Cor. St. Francis St., Mandaluyong City, represented herein by its authorized representative, RAVEN LUIS L. VIDAS, (hereinafter called "ORDENT"), duly authorized for this purpose as evidenced by **ORDENT** Secretary's Certificate, copy attached hereto as Annex "B".


WHEREAS, PHILHEALTH invited Bids for certain goods and ancillary services particularly on the Procurement of Various Supplies for Health and Medical **Emergencies** and has accepted a Bid by **ORDENT** for the supply of those goods in the sum of, ONE MILLION FOUR HUNDRED SEVENTEEN THOUSAND SIX HUNDRED TWENTY PESOS (PhP1,417,620.00) (hereinafter called "the Contract Price").

On October 27, 2021, PhilHealth caused the posting of an Invitation to Bid for the Procurement of Various Supplies for Health and Medical Emergencies with an Approved, Budget of the Contract (ABC) in the amount of One Million Five Hundred Twenty-Two Thousand Two Hundred Ninety-Three Pesos (PhP1,522,293.00) in accordance with its 2021 Annual Procurement Plan.

Two (2) bidders submitted their bids on or before November 16, 2021. After opening the bids, ORDENT was declared eligible having submitted the Lowest Calculated Bid (LCB).

PhilHealth subjected to post-qualification and after such proceedings, ORDENT's bid in the amount of ONE MILLION FOUR HUNDRED SEVENTEEN THOUSAND SIX HUNDRED TWENTY PESOS (PhP1,417,620.00) was found to be the Lowest Calculated and Responsive Bid.

PhilHealth subsequently issued the Notice of Award to ORDENT which the latter accepted on May 12, 2022.






NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:

 - (ii) Annual Income tax Return (ITR) for CY2020 (Annex "X");
 - (iii) Quarterly Income Tax Return (BIR Form No. 1702Q) and Monthly Value Added Tax Declaration (BIR Form No. 2550-M) (Annex "Y"); and
 - Proof of Payment of PhilHealth Premium Contribution (Annex "Z").
 - Other contract document that may be required by existing laws and/or the (i) PHILHEALTH in the PBDs. ORDENT agrees that the additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of ONE MILLION FOUR HUNDRED SEVENTEEN THOUSAND SIX HUNDRED TWENTY PESOS (PhP1,417,620.00) (Annex "D") or







such other sums as may be ascertained, **ORDENT** agrees to provide the goods and services and to remedy defects therein within the warranty period in accordance with their Bid.

- 4. **PHILHEALTH** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. **ORDENT** holds **PHILHEALTH** free and harmless from any claim, obligation or liability that may be caused to any third party that may be injured or harmed due to the willful, unlawful or negligent act or omission of **ORDENT** or any of its personnel or representative, without prejudice to any other legal action that **PHILHEALTH** may have against **ORDENT** for, in relation to the implementation of the Contract.
- 6. If any dispute or difference of any kind whatsoever shall arise between the parties in connection with the implementation of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

Any dispute that is not settled amicably shall be submitted to arbitration in the Philippines according to the provisions of R.A. 876, otherwise known as the "Arbitration Law" and R.A. 9285, otherwise known as the "Alternative Dispute Resolution Act of 2004".

Whenever necessary to promote Arbitration or to seek judicial relief, **PHILHEALTH** and **ORDENT** agree that any legal action, suit or proceeding arising out of or relating to the Contract may be instituted in any competent court where the principal office of **PHILHEALTH** is situated, to the exclusion of other courts of equal jurisdiction.

- 7. Attorney's Fee In the event that **PHILHEALTH** is compelled to commence arbitration or to seek judicial relief to enforce the provisions of the Contract, it shall be entitled to attorney's fees and liquidated damages equivalent to ten percent (10%) and fifteen percent (15%), respectively, of the contract price or the amount claimed in the arbitration or judicial action, whichever is higher, aside from the cost of arbitration or litigation, whichever is applicable, and other expenses incidental thereto.
- 8. EFFECTIVITY CLAUSE. This Agreement shall take effect upon signing thereof by the Parties and **ORDENT** shall commence performance of its obligations upon the issuance by **PHILHEALTH** of a Notice to Proceed.
